# Second quarter fuels Warrensburg against Cameron

CAMERON — The sight of the ball coming loose became familiar in the second quarter - at least for one of the teams on the field.

Warrensburg found itself on the beneficiary end, using a pair of scoop and scores to pull away to a 42-6 win against Cameron on Friday, Sept. 5, at Dave Goodwin Field.

"The defensive pressure there in the second quarter kind of turned the game in our favor," Warrensburg head coach Chris Cavanah said. "Our kids played great and found a way to make some plays. I'm happy for the win."

The pair of defensive touchdowns arrived on backto-back drives in the second quarter.

With Warrensburg (1-1) leading 14-6, senior defensive back Cruz Villegas came up with the first, returning the ball 45 yards for a touchdown.

A minute later, sophomore Dominik Maham came up with the second.

The ball Maham grabbed appeared to be rolling towards the sideline whenever he picked it up for a 16-yard return.

"We've got some athletes on that side of the ball," Cavanah said. "Dominik is very skilled with the football in his hands."

Cameron (1-1) lost grip of the ball, but fell back on it several other times in the first half.

Senior Frank Stephenson came up with a third fumble recovery for the Tigers in the third quarter.
